

Terms and Conditions

Hot 100's Golden Ticket 2019

Your participation in the Hot 100 Golden Ticket Promotion 2019 ('the Competition') constitutes deemed acceptance of the following terms and conditions:

1. By entering, you acknowledge that each entrant has an equal chance of winning the prize and the winner will be drawn by Hot 100.
2. The Promoter of the Competition is Hot 100. Hot 100, reserves the right, at any time, to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
3. **To be eligible to enter the Competition you must listen to Hot 100FM 100.1 Monday - Friday across the work day to find out where you can get your Golden Ticket from. On Wednesday June 5 at 8:00am Hot 100 will randomly draw one Golden Ticket as the winning ticket, should the entrant not contact the station within the specified 60-minute time frame, another ticket will be re-drawn until a successful entrant has come forward. The competition will be active from midnight April 22 and ends midnight Sunday June 1 2019.**
4. By entering you consent to the Promoter collecting your personal details. You will receive email updates containing information relevant to the promoter and you will have the option to unsubscribe from these updates. All entries become the property of the Promoter.
5. Entrants can enter the competition as many times as they like.
6. The Competition commences **midnight on June 1 2019.**
7. One prize winner will be announced on air at 8:00am on Wednesday June 5 2019.

 - Entry (2 tickets) for the winner and one other guest to attend any event listed on Hot 100's Golden Ticket event listing.
